MINI BUDGET 2022 -

AN UPDATE



On 23 September, the Chancellor, Kwasi Kwarteng, revealed some tax cuts as part of his mini budget revealed as The Growth Plan.

The following turmoil in the financial market resulted in the Government making several U-turns, and Jeremy Hunt replaced Kwarteng. Here is a summary of what is happening with each of the measures:

INCOME TAX

What was announced:

- The Government was going to cut the basic income tax rate to 19% from April 2023.
- The 45% higher income tax rate for earnings over £150,000 was going to be abolished for England, Wales, and Northern Ireland taxpayers.

What has changed:

- The basic rate of income tax will remain at 20%.
- The cut is no longer going ahead, and the 45% higher income tax rate will remain.

CORPORATION TAX

What was announced:

The Chancellor had planned to cancel the rise of corporation tax to 25% from April 2023.

What has changed:

• The rise will go ahead as planned, and the corporation tax will increase to 25% in April 2023.

IR35

What was announced:

• The Government had promised to change the IR35, so companies were no longer responsible for ensuring their contractors were paying the right amount of tax.

What has changed:

• The reform will no longer go ahead, and the rules surrounding IR35 will remain the same.

NATIONAL INSURANCE (NI)

Effective 6 November, the Chancellor is removing the 1.25% NI Contributions increase, which was earmarked for the Social Care Levy.

ANNUAL INVESTMENT ALLOWANCE

The £1 million allowance will remain permanent rather than returning to £200,000 in March 2023. This gives 100% tax relief to businesses on their plant and machinery investments up to the higher £1 million limit.



STAMP DUTY/LAND TRANSACTION TAX

Stamp duty has been cut for those in England and Northern Ireland. No stamp duty will be due on the first £250,000, and for first-time buyers, that rises to £425,000.

For those in Wales, the starting threshold for paying the main residential rates of LTT increases from £180,000 to £225,000, and the first tax band will cover transactions from £225,000 to £400,000, taxed at 6% on the amount over £225,000.

SEED INVESTMENT SCHEME (SEIS)

New companies will now be able to raise up to £250,000, giving tax relief to investors.

Further changes to the fiscal policy will be announced on 31 October as part of the Autumn Budget.

THE ENERGY RESILIENCE GRANT

The Energy Resilience Grant has been launched to help businesses invest in equipment and their buildings to reduce their energy consumption.

The grant is available to manufacturers employing between 10 and 100 people (including partner enterprises and corporate ownership) located in the unitary authorities of Blaenau Gwent, Bridgend, Caerphilly, Cardiff, Merthyr Tydfil, Monmouthshire, Newport, Rhondda Cynon Taf, Torfaen and the Vale of Glamorgan.

The maximum award is up to £25,000 or 70% of eligible costs, whichever the lower. Eligible expenditure can include renewables, boiler equipment, motors and drives and uninterruptable power supplies amongst others. For a more detailed list please visit.

DEALING WITH DATA PROTECTION **COMPLAINTS AS A SMALL BUSINESS**



The Information Commissioner's Office (ICO) have published new material on their **SME hub** about handling data protection complaints, including guidance on six key steps to take if you are the subject of a complaint.

Even with appropriate data protection policies in place, sometimes your staff, contractors, customers or others whose data you hold may be unhappy with how you've handled their personal information. Your response matters, because taking the right steps will help to protect your reputation as a business that cares about people's information. This will also help you provide a better service to your customers.

The guide has been written to help small businesses deal with complaints about how they've used people's information. If you're a small charity, small group or club, or small organisation, you'll also find it useful.
