The Torfaen Kickstart Scheme **will fund a new job role** for 16-24 year olds to learn essential skills & gain valuable experience.

Bydd Cynllun Kickstart Torfaen **yn ariannu swydd newydd** i bobl ifanc 16-24 oed ddysgu sgiliau hanfodol a chael phrofiad gwerthfawr.

What is it? | Beth yw hyn?

Central Government have allocated £2 billion in funding to create hundreds of thousands of high quality **6-month work placements** for young people (16 – 24).

Funding is available through the DWP for each job and will cover the relevant **National Minimum Wage for 25 hours a week**, plus the associated employer National Insurance contributions and

Applications for funding must be for a minimum of 30 job placements.

Torfaen County Borough Council can act as a '**Gateway**' representative for local employers to make the scheme viable.

As the gateway representative Torfaen Kickstart Scheme will:

- Help you manage the process, make applications and draw down funding on your behalf.
- Work with you to:
 - identify appropriate job placement opportunities (as per the funding requirements)
 - Consider how you will provide a safe, appropriate

Fel cynrychiolydd porth bydd Cynllun Kickstart Torfaen yn:

- Eich helpu i reoli'r broses, gwneud ceisiadau a chael arian ar eich rhan
- Gweithio gyda chi i:
 - nodi cyfleoedd priodol am leoliadau (yn unol â'r gofynion ariannu)

and meaningful work placement for the young person

- Contribute towards necessary set up costs, e.g. resources or equipment

- Induct and provide essential skills training.
- Provide additional workplace mentoring to ensure a successful placement experience for both you and the young person.

- Cyfrannu at gostau cychwynnol angenrheidiol e.e. adnoddau neu gyfarpar

Is my Business Eligible? | Ydy fy musnes yn gymwys?

To be eligible you must have a Companies House or Charity registration number and:

- Provide a new*¹ job placement for a minimum of 25 hours (National Minimum Wage) and initially pay the salary costs*²
- Ensure a suitable and meaningful placement, and support the young person to develop skills and experience which they can use as a stepping stone into work, training or further education.

*¹ Job placements **must be new** or surplus opportunities. They must not replace existing or planned vacancies.

*² Employers are required to **pay the salary costs initially** and will be reimbursed monthly.

I fod yn gynnwys rhaid bod gennych rif cofrestrriad Elusennol gyda Thŷ'r Cwmnïau a:

- Chynnig lleoliad gwaith newydd*¹ am o leiaf 25 awr (Isafswm Cyflog Cenedlaethol) a thalu'r costau cyflog i gychwyn*²
- Sicrhau lleoliad addas ac ystyrlon, a chefnogi'r person ifanc i ddatblygu sgiliau a phrofiad y gallan nhw eu defnyddio fel carreg sarn tuag at waith, hyfforddiant neu addysg bellach.

*¹ Rhaid i leoliadau gwaith **fod yn newydd** neu'n gyfleoedd ychwanegol. Ni ddylen nhw fod yn cymryd lle swyddi gwag presennol neu rai a gynllunnir.

*² Bydd rhaid i gyflogwyr **dalur costau cyflog i gychwyn** a byddan nhw'n cael eu had-dalu pob mis.
